### FURTHER PARLIAMENTARY REPORT ON FRANCHISING IN SOUTH AUSTRALIA

The Economics and Finance Committee of the South Australian Parliament, which has been inquiring into whether recent changes to the national Franchising Code of Conduct had addressed recommendations made by the Committee in 2008, has now released its report. The Shopping Centre Council made a submission to this inquiry. While the Committee found many of the earlier recommendations had not been addressed, that's not surprising since those recommendations went way beyond what is necessary to effectively regulate the franchising industry. There has been no further advice from the SA Government on whether it intends to proceed with a draft Bill to regulate franchising in that State (Shop Talk 27/1/11). The Federal Minister for Small Business, Senator Nick Sherry, recently urged both South Australia and Western Australia "to refrain from passing their own legislation and instead join the rest of their state and territory colleagues in getting behind the national system and provide certainty for the industry". Senator Sherry noted Australia already has an effective national regulatory system for franchising. A Parliamentary Committee in WA has now recommended against introduction of state-based legislation in that State (Shop Talk 30/6/11).

## QUEENSLAND COUNCILS BREACHING LAW ON DIFFERENTIAL AND MINIMUM RATING

The Shopping Centre Council has written to all Queensland councils where our members have centres to outline our concerns with 'differential' and 'minimum' rating, as we believe some councils are breaching the law. Under the Local Government Act, councils must rate in accordance with relevant principles, linked with the impact on council resources and the level of services provided. We are of the strong view that some local councils are departing from these requirements, by incorrectly using the 'minimum rating' approach, and using the 'differential rating' approach based on 'capacity to pay' principles. Councils have been setting 'minimum' rates to overcome the uncertainty with land valuations, however with increased certainty under the new legislation and methodology, there can be no justification for continuing the current approach. The 'capacity to pay' approach was tested last year in Queensland's Court of Appeal, where Xstrata successfully argued that the council had considered its 'capacity to pay' in setting rates, as opposed to legitimate criteria relating to land use characteristics. We are closely monitoring this practice.
