# LONG-AWAITED NEW PLANNING BILL INTRODUCED INTO NSW PARLIAMENT

The NSW Minister for Planning, Brad Hazzard MP, achieved a major milestone this week when he introduced into Parliament the long-awaited Planning Bill 2013, intended to introduce a new land planning, development assessment infrastructure contributions system for NSW. The Bill is a key element of the Government's planning platform at the 2011 State election. Mr Hazzard stated in Parliament this week that the Bill "will bring NSW out of the Dark Ages of planning and into a modern, responsive system that places power back in the hands of communities and delivers on our election commitments". While Mr Hazzard has consistently stressed the new system will elevate strategic planning - which should be applauded the Bill provides little comfort in some areas. New NSW Planning Policies are proposed, which will include an Employment Policy (which will include a retail component), to guide lower order regional, sub-regional and local plans. However the Bill has removed some elements that were in the Exposure Draft Bill which potentially means that such Policies cannot have provisions which relate to development assessment. While an improved focus on strategic planning is welcome, a focus on development assessment is also necessary, given some of the road-blocks to retail development at the local council level, which will take some time (and government commitment) to influence and change. Even where retail is clearly proposed to grow which is often highlighted in a regional and local plan - councils can then impose local restrictions that make the achievement of such growth cumbersome and costly (such as floor space caps, urban design, use mixes and infrastructure contributions). It is hoped the Government pays attention to such commercial development issues, as it seems to do for housing. The Bill is expected to be strongly debated, particularly in the Legislative Council, and may possibly be referred to a parliamentary committee for closer examination.
